Washington, 5th Floor, Phoenix, AZ 85007.

DEFINITIONS

- 1 **In-state** producer's license to manufacture or produce spirituous liquor in this state.
 - 2 **Out-of-state** producer's license, to manufacture or produce spirituous liquors.
 - 3 **Microbrewery**.
 - 4 **Wholesaler's** license, to sell spirituous liquors.
 - 5 **Government** license issued in the name of a county, city or town.
 - 6 **Bar license**, which is an on-sale retailer's license to sell all spirituous liquors by individual portions and in the original containers.
 - 7 **Beer and wine bar** license, which is an on-sale retailer's license to sell beer and wine by individual portions and in the original containers.
 - 8 **Conveyance** license issued to an operating railroad, airline and boat companies.
 - 9 **Liquor store** license, which is an off-sale retailer's license to sell spirituous liquors.
 - 10 **Beer and wine store** license, which is an off-sale retailer's license to sell beer and wine.
 - 11 **Hotel-motel** license issued as such, to sell and serve spirituous liquors solely for consumption on the licensed premises.
 - 12 **Restaurant** license issued as such, to sell and serve spirituous liquors solely for consumption on the licensed premises of the restaurant.
 - 13 **Domestic farm winery** license.
 - 14 **Private Club** license issued in the name of a bona fide club, qualified under state law to sell all liquors on-sale.

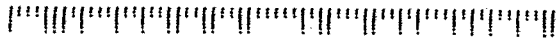
"On-sale retailer" means any person operating an establishment where spirituous liquors are sold in the original container for consumption on or off the premises or individual portions for consumption on the premises.

"Off-sale retailer" means any person operating a bona fide regularly established retail store which is engaged in the sale of alcohol (only in the original, unbroken package) which is meant to be taken off the premises of the retailer and consumed at another location.

Council Meeting Attendance

In addition to your written argument, you should also attend the City Council meeting when the application is scheduled to be considered. When you arrive at the City Council Chambers, complete a speakers card available at the rear of the Council Chambers. Once completed, please deliver the speakers card to the City Clerk staff person located at the front of the Council Chambers. At the appropriate time, you will be asked to come forward to speak to the City Council regarding your position about the item.

Whether written or verbal, your communication should always include your name and address, the applicant's name, business name and address, and a clear statement of whether you are in favor of or opposed to the issuance of the permit and why.

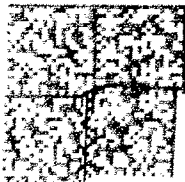
